<b>Application Fee</b> (payable with application and non-refundable)	\$200

<b>Homestay Fees</b> (homestay receives a full amount each month)	\$12,000 (\$1,200 per month)

<b>Application Fee</b> (payable with application and non-refundable)	\$200
<b>Program Fee</b> (5 months /including medical insurance)	\$8,450 (\$1,690 per month)
<b>Annual Homestay Management Fee</b> (non-refundable within 90 days of program start)	\$500
<b>Homestay Fees</b> (homestay receives a full amount each month)	\$6,000 (\$1,200 per month)
<b>Custodian Fee</b> (for students in Delta Homestay)	\$500
<b>Airport Pick-up and Drop-off Fee</b>	Free for homestay students

- All fees are subject to review and change each year. Additional fees are added when students attend summer courses.
- Returning students are subject to a \$100 renewal fee and \$240 for summer medical insurance.
- Extending students are also subject to a \$100 extension fee.
- For students staying with parents who require custodian documents for IRCC purposes, a one time \$200 fee will be charged.
- All fees are due at least 90 days before program start.

# Refund Policy

*All requests for refunds must be made in writing to Delta School District's International Student Program.*

- Full refund of the program fee (less the \$200 application fee) if the Student Authorization is not approved by Canadian Immigration. The student must submit an original copy of the letter of rejection from the High Commission / Canadian Consulate General / Canadian Embassy. Refunds will not be granted without this letter for any reason.
- One-half (50%) of the program fee is refunded if the student withdraws prior to the start of the program, including change in immigration status and including parent work permit, study permit or PR status.
- One-half (50%) of the program fee is refunded if the student withdraws before the end of the first calendar month of the program for any reason, including change in immigration status and including parent work permit, study permit or PR status.
- No refund of the program fee is given (for any reason) after the student has attended for one month, including change in immigration status and including parent work permit, study permit or PR status. This includes any program fees paid for future school terms.
- No refund of the program fee is made if the student is dismissed from the program as a result of a breach of the terms and conditions of the agreement.
- It is required that students give host families at least 2 weeks' notice if they intend to move out or remunerate them with 2 weeks' payment. Students who are dismissed or leave the program are responsible for payment for the rest of the month or 2 weeks, whatever is the greater, calculated from after they depart the homestay.
- Application fees are non-refundable. Annual Homestay Management fees and Custodianship fees are not refundable within 90 days of program start date.
- All refunds will be subject to a \$500 administration and processing fee with the exception of a study permit or visa rejection.
- Deferrals are rare and granted at the discretion of the Director after full review of the application, payment history and study permit and visa application history. If granted, there is a \$500 fee for a deferral above any difference in fees from the original study period.
